In June 2014 the Chilean Association of Independent Loss Adjusters ("ALOSI") assumes the Presidency of the IFAA. Currently ALOSI is the first, and only, Latin American adjusting association in the IFAA. Founded in 1966, its members are individual loss adjusters who have completed the respective exam of Chile's Securities and Insurance Superintendence ("SVS") and who have pledged to abide by the Association's Code of Ethics.

ALOSI maintains fluid communication with the SVS with regards amendments to the applicable legislation, such as the new Regulations for the loss adjustment procedure and the new Insurance Law. Communication is more intense at times of catastrophes, such as the 2010 earthquake/tsunami.

ALOSI continuously supports seminars organised by Chile's Association of Insurers, the most recent being "Lloyd's Chile Insurance Day" in London and also the local/international courses of their Insurance School.

ALOSI is looking forward to working closely with the Member Associations of the IFAA, and encouraging other adjusting associations in Latin America to join the IFAA.
